**INVITATION TO BID**  
**Procurement of PATROL CAR for the Ministry of Public Order  
and Safety - BARMM**

1. The Ministry of Public Order and Safety, Bangsamoro Autonomous Region in Muslim Mindanao (MPOS-BARMM), through the General Appropriations Act for the Bangsamoro 2022 intends to apply the sum of **Nine Million Pesos only (PHP 9,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Procurement of Patrol Car for the Ministry of Public Order and Safety - BARMM**.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The MPOS-BARMM now invites bids for the **Procurement of Patrol Car for the Ministry of Public Order and Safety - BARMM**. Delivery of the Services is specified in Section VI. Schedule of Requirements. Bidders should have completed, within five (5) years prior to the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from the Ministry of Public Order and Safety (MPOS) and inspect the Bidding Documents at the address given below during office hours, 8:00AM-5:00PM, Monday to Friday.

5. A complete set of Bidding Documents may be acquired by interested Bidders starting **May 31, 2022, 8:30 a.m.** from the given address and website(s) below upon payment of the applicable fee for the Bidding Documents, in the amount of Six Thousand Pesos (PHP 6,000.00), pursuant to the latest Guidelines issued by the GPPB. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
6. The MPOS-BARMM will hold a **Pre-Bid Conference on June 7, 2022, 10:00 a.m. at Givfrell Building, Gov. Gutierrez Ave., RH7, Cotabato City**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, **on or before June 15, 2022, 10:00 a.m.** Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **June 15, 2022, 10:00 a.m.** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The MPOS-BARMM reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
