Gutierrez Ave., Cotabato City, Philippines, represents herein by the Minister, HUSSEIN P. MUÑOZ, hereinafter called the "**MPOS-BARMM**".

**Fibra de Vidrio Gasan Inc.**, a corporation duly organized under and by virtue of the laws Republic of the Philippines, with office 43 Sto Rosario St., Buhangin, Davao City, Philippines, represented herein by its Owner, John Mar Dominic E. Diana hereinafter called the "**SUPPLIER**".

**WITNESSETH**

**WHEREAS**, the "**MPOS-BARMM**" invited Bids for the "Procurement of Watercraft (5 units) under PBD No. MPOS-BARMM-2022-03" has accepted the Bid of the "**SUPPLIER**" for the supply and delivery of "Five Unit (5) Watercraft".

In the sum of **Eight Million Seven Hundred Thirty Thousand Pesos Only (P 8,730,000.00)** hereinafter called the "**Contract Price.**"

**NOW THEREFORE**, in view of the foregoing premises and of the mutual covenants and stipulations, hereinafter provided, the parties here to have agreed, as follows:

  - (b) The Scheduled of Requirements;

  - (d) The General Conditions of the Contract;
  - (e) The Special Conditions of Contact and
  - (f) The Entity's Notification of Award

The "MPOS-BARMM" hereby covenants to pay the "SUPPLIER" in consideration of the provision of the goods and services and to the remedying of defects therein, the "Contract Price" or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the day and year first above written.


