ARIAZ GENERAL MERCHANDISE, a corporation duly organized under and by virtue of the laws Republic of the Philippines, with office Sausa Extension, RHXII, Cotabato City, Philippines, represented herein by its Owner, **AL BRINJI BEDERI MALI** hereinafter called the "**SUPPLIER**".

WITNESSETH

WHEREAS, the "**MPOS-BARMM**" invited Bids for the "Procurement of Information Communication Technology Equipment under PBD No. MPOS-BARMM-2022-01" has accepted the Bid of the "**SUPPLIER**" for the supply and delivery of "Service Vehicle(Van)".
