## Invitation to Bid Procurement of ICT EQUIPMENT for the Ministry of Public Order and Safety – BARMM

ITB No.: MPOS-2022-01

1. The Ministry of Public Order and Safety, Bangsamoro Autonomous Region in Muslim Mindanao (MPOS-BARMM), through the General Appropriations Act for the Bangsamoro 2022 intends to apply the sum of One Million Three Hundred Seventy-Five Thousand Pesos only (PHP 1,375,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Procurement ICT Equipment of the Ministry of Public Order and Safety - BARMM.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2. The MPOS-BARMM now invites bids for the Procurement of ICT EQUIPMENTS for the Ministry of Public Order and Safety - BARMM. Delivery of the Services is specified in Section VI. Schedule of Requirements. Bidders should have completed, within three years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from Ministry of Public Order and Safety and inspect the Bidding Documents at the address given below during office hours, 8:00AM-5:00PM, Monday to Friday.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on January 25, 2022, 8:30 a.m. from the given address and website(s) below upon payment of the applicable fee for the Bidding Documents, in the amount of Five Thousand Pesos (PHP 5,000.00), pursuant to the latest Guidelines issued by the GPPB. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
