3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from **MPOS BARMM** and inspect the Bidding Documents at MPOS BARMM 2/F Givfrell Bldg., Gov. Gutierrez Ave., Cotabato City during weekdays from 8:00AM to 5:00PM.
5. A complete set of Bidding Documents may be purchased by interested Bidders from **August 11, 2022** until **August 25, 2022**, but not later than 10:00AM of the deadline from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount stated above.
6. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) (<https://www.philgeps.gov.ph>) provided, that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
7. The **MPOS BARMM** will hold a Pre-Bid Conference on **August 18, 2022 at 10:00AM** at **MPOS BARMM Conference Room, 2/F Givfrell Building, Gov. Gutierrez Ave., Cotabato City** which shall be open only to all interested parties who have purchased the Bidding Documents.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in Instruction to Bidders (ITB) Clause 18.
9. Bid opening shall be on **August 25, 2022 at 10:00AM** at **MPOS-BARMM 2/F Givfrell Building, Gov. Gutierrez Ave., Cotabato City**. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below (Item 9). Late bids shall not be accepted.
10. The **MPOS BARMM** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.


