

Contract Agreement Form for the Procurement of Infrastructure Projects

CONTRACT AGREEMENT

THIS AGREEMENT, made this _____ day of September, 2024 between Ministry of Public Order and Safety - BARMM with address Givfrell Building, Gov. Gutierrez Ave., RH VII, Cotabato City (hereinafter called the "Entity") and Angkat Construction and Supply with address Catalina Austria Street, RH 10, Catabato City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the **CONSTRUCTION OF BANGSAMORO MEDIATION CENTER, PARANG, MAGUINDANAO DEL NORTE with Contract ID: MPOS-BARMM-CW-SDF2022-002** and the Entity has accepted the Bid for **Four Million Six Hundred Fifty Three Thousand Three Hundred Forty Four Pesos and 9/100 centavos (PhP 4,653,344.09)**.by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:

- a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;

b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted, including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

c. Performance Security;

d. Notice of Award of Contract and the Bidder's conforme thereto; and

e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **Four Million Six Hundred Fifty Three Thousand Three Hundred Forty Four Pesos and 9/100 centavos (PhP 4,653,344.09)** or such other sums as may be ascertained, **ANGKAT CONSTRUCTION AND SUPPLY** agrees to the **CONSTRUCTION OF BANGSAMORO MEDIATION CENTER, PARANG, MAGUINDANAO DEL NORTE** in accordance with his/her/its Bid.
